They have a long runway for growth available to them.

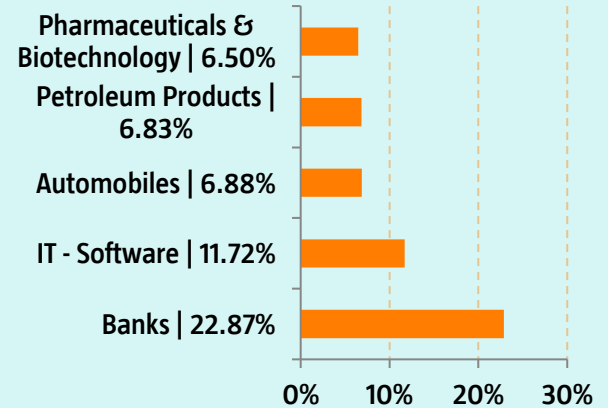

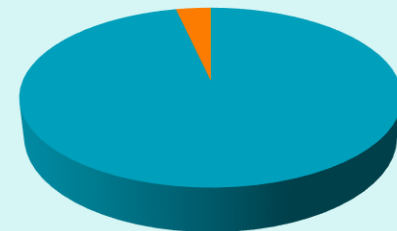

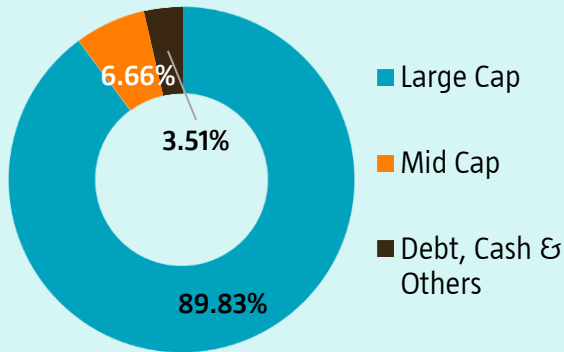
