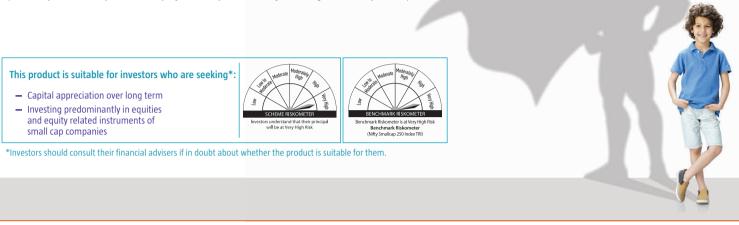

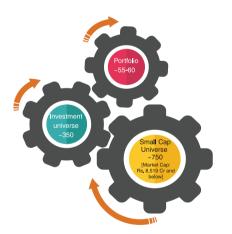
# **CANARA ROBECO SMALL CAP FUND**

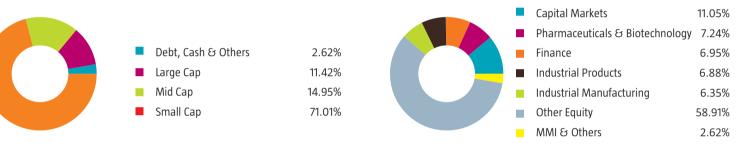
MARKET CAPITALIZATION (as on 28th March, 2024)
