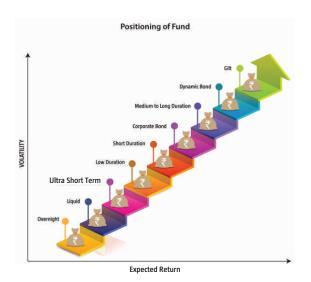

These funds have average maturity lower than long-duration funds / gilt funds, but usually more than Liquid Funds. Additionally, as the investment strategy in these funds is to generate accrual income, such funds are less sensitive to changes in interest rates. This reduces the volatility of returns making them a suitable solution to park short term surplus.

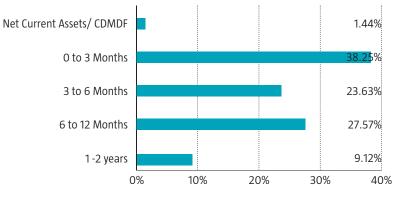
# Why Canara Robeco Ultra Short Term Fund?

Canara Robeco Ultra Short Term Fund is an open-ended ultra-short term debt scheme investing in instruments such that the Macaulay duration of the portfolio is between 3 months and 6 month. The fund is a well-diversified fund which aims to identify securities with the intention to hold the investments till maturity; thereby reducing the risk arising from fluctuating interest rates.
